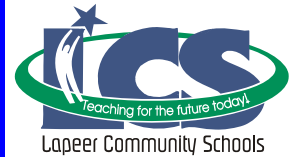

Principal's Notes ...

Dear Turrill Students and Families,

As we move through the school year, the data that teachers are showing me is amazing in regards to academics. As a staff, each grade level spends time together collaborating and searching for ways to increase student learning. This frequent collaboration is something that will continue to ensure all students are successful with their learning. Collaboration also offers clear direction for additional staff members who are working with students either during the RtI time, which is 30 minutes per day, or other group time during the course of the day.

During the collaboration time the grade level teachers, along with interventionist and special education teachers meet to discuss student data from that grade level. Also, during the collaboration time, the teachers move through a process where they answer one of the four questions: 1. What do we want our students to learn? 2. How will we assess what our students know? 3. What is our plan for responding to students who need more support? 4. What is our plan for responding to students who already know what we want them to know? These four questions, as simple as they seem, push the work of the grade level to be very purposeful in what they are teaching. Answering these questions also help teachers find ways to offer interventions and enrichments. As a result of the collaboration time the teachers create essentials, or what they want students to learn, interventions, and/or enrichments. Interventions are for the students who need more support and the enrichment groups are for the students who need more of a challenge. At the conclusion of their time, they have a plan for whole class instruction, interventions and enrichments for all students during the day.

I am extremely confident that as the year continues, and into future years, the level of enrichment for all students will increase. As a principal, this is something that I am very excited for. It shows that we are meeting each individual students needs and pushing everyone forward. The process of collaboration will offer this guidance for all staff members as they plan individual instruction for not only our struggling students, but all students.

Spots are limited and pre-registration is required. A minimum of 2 business days is required to process paperwork before your child can begin the program. Call (810) 667-2454 or go to www.Lapeerschools.org and click on Kids and Company for more information. Please call in advance to make sure there are spots available. All families interested in using Kids & Company for childcare need to ensure that all registration requirements are met. These requirements are for families interested in using the program regularly as well as for childcare on the delayed start days and additional days off, including September 28th and October 1st.

MEAP 2012

Students in grades 3rd through 5th will be participating in the MEAP assessment during the month of October. Students in grades 3rd through 5th will be assessed in the areas of reading and math. In addition to these assessments, students in 4th grade will also take a writing assessment and 5th grade students will take the science assessment. The testing window will be from October 9th through October 17th with makeup days that follow. During this testing window, please do your best to make sure that your child is in attendance.
